Born in Montevideo, Uruguay. Attorney and Doctor of Law and Social Sciences from the *Universidad de la República Oriental del Uruguay*, Mr. Acle has undertaken post-graduate studies in International Law with the Inter-American Juridical Committee in Rio de Janeiro and the University of London, as well as in the area of Consumer Law at the *Universidad Pompeu Fabra* in Barcelona.

After practicing law in private firms and the United Nations Development Programme in Uruguay, he joined the Organization of American States (OAS) where he coordinated the Program on Access to Justice for Vulnerable Groups in the Department Special Legal Programs. Currently, he is a Specialist at the Department of Social Development and Employment of the OAS in charge of the Consumer Protection Program and the Technical Secretariat of the Working Group on Human Rights of Older Persons, which has the mandate to prepare a draft Inter-American Convention on the subject.
