## Aging Activism: A Global Tool to Create a Society for All Ages

The international community, using the strengths of every generation, has taken up the challenge and task of building a society for all ages – a global environment which fosters stability, justice and the provision of social and economic security for all, while recognizing the unique needs and abilities of older persons. The 2009 International Day of Older Persons focuses on mobilizing the often unrecognized dynamism, intellect and power of older persons to maximize their participation in society and to improve the quality of life for themselves and for all generations.

Issues for Exploration and Debate:

## Promoting Activism to Create a Society for All Ages

- Throughout the ages, activism by the world's citizens has been one of the primary reasons that humanity has progressed. Particularly true today, we need the activism of older persons to ensure not only that their unique needs are acknowledged and addressed, but also that the legacy of older persons protects the innumerable ways they have improved this world for current and future generations.
- By *Strengthening Human Rights of Older Persons*, older persons, in partnership, can improve life for the world's fastest growing population demographic cohort. This challenge recognizes that ageing is a process each one of us faces and is essential to persons of every generation.

## Strengthening Existing Mechanisms to Ensure a Society for All Ages

- Globally, much has been accomplished to acknowledge the need to move toward an inclusive society for all ages, particularly with regard to older persons. As older persons, and those who are becoming older, we know that the purpose of our continuing work in the international community is to ensure that those people and ideas worthy of protection are protected.
- Understanding how various internationally sanctioned protective measures operate and how they are blueprints for the future is essential in establishing a society for all ages. For example, the *Madrid International Plan of Action on Ageing* and *the United Nations Principles on Ageing* deserve particular attention to help educate and motivate policy makers and citizens to create a society for all ages.

## Confronting Emerging Challenges for a Society for All Ages

- Challenges not fully recognized even two decades ago are now at the top of the international agenda. Working across the generations to create positive change is critical to humanity's ability to "progress", survive and thrive.
- For example, understanding how *older persons are affected by climate change* as well as how they can positively help rehabilitate the planet is one challenge needing attention and the substantial intellectual resources of an aging world.
- Securing basic Social Services for Older Persons in Developing Nations, acknowledging how all generations benefit from provision of services for older persons.

## THE SECRETARY-GENERAL \*\*\* MESSAGE ON THE INTERNATIONAL DAY OF OLDER PERSONS <u>1 October 2009</u>

"Celebrating the 10th Anniversary of the International Year of Older Persons: Towards a Society for All Ages"



This year marks the 10<sup>th</sup> Anniversary of the International Year of Older Persons.

Over the past decade, we intensified our efforts to build a "society for all ages" and to promote international commitment to the United Nations Principles for Older Persons. The Principles are founded on the need to build an inclusive society that emphasizes participation, self-fulfillment, independence, care and dignity for all. To transform them into deeds, we have campaigned for policies that will enable older persons to live in an environment that enhances their capabilities, fosters their independence, and provides them with adequate support and care as they age.

The motto "towards a society for all ages" was adopted in 1999 and reaffirmed at the Second World Assembly on Ageing, held in Madrid in 2002. It emphasizes the need to treat older persons as both agents and beneficiaries of development.

This emphasis – and the United Nations Principles – take on even greater importance as the world struggles to confront global food, energy, climate, financial and economic crises.

The international community is also devoting increasing attention to the human rights of older persons. We must put an end to age discrimination, abuse, neglect and violence against older persons. I urge states to put the necessary legal protections in place, and I urge all partners to help countries develop the capacity and institutions to achieve this objective.

On this International Day, let us reaffirm our commitment to the vital work of upholding the UN Principles for Older Persons and achieving a society for all ages.

## SPEAKERS Morning Program



**Kiyotaka Akasaka** joined the United Nations in 2007 when he was appointed as Under-Secretary-General for Communications and Public Information. In May 2008, the Secretary-General appointed Mr. Akasaka as Coordinator of questions relating to multilingualism throughout the UN Secretariat. These functions are in addition to his current responsibilities as head of the Department of Public Information (DPI).

Prior to his current post, Mr. Akasaka held the position of Deputy Secretary-General of the Organization for Economic Cooperation and Development (OECD) from August 2003 to March 2007. He was Japan's Ambassador to the UN from 2000 to 2001 and served as a bureau member for the preparation of the World Summit on Sustainable Development, held in Johannesburg in 2002.

In 1997, Mr. Akasaka was appointed the Deputy Director-General of the Japanese Foreign Ministry's Multilateral Cooperation Department, in which capacity he served

as one of his country's senior negotiators in the Kyoto Conference on Climate Change. From 1993 to 1997, he served as an official with the World Health Organization (WHO) and from 1988 to 1991 he was a member of the Secretariat of the General Agreement on Tariffs and Trade (GATT), the precursor of the World Trade Organisation.

Mr. Akasaka is the co-author of several books, including *The GATT and the Uruguay Round Negotiations* and *The Cartagena Protocol on Biosafety*, and has also written many articles on trade, the environment and sustainable development.

Kiyotaka Akasaka is a national of Japan. In addition to Japanese, he speaks English and French.



**Jessica Frank López, Chair**, CoNGO Committee on Ageing, joined AARP in 2000 and serves as Director of the AARP Office of International Affairs in New York which is focused on informing domestic policy discussion with international best practices and policies. The Office of International Affairs also works to raise AARP's profile internationally by sponsoring and participating in international social and economic policy debates worldwide. Ms. Frank is the primary liaison to the United Nations and with the Latin American region for AARP, the largest non-profit organization in the United States which has 40 million members and representing people 50 years of age and older. Ms. Frank's portfolio of work includes overseeing AARP's international work on long-term care issues identifying and promoting best practices in long-term care.

At the UN, Ms. Frank manages a team of high-level volunteers to advocate to government delegates on issues pertinent to older populations. On behalf of AARP's

International Office, Ms. Frank has organized and participated in several major international conferences including the United Nations Second World Assembly on Ageing and the United Nations International Day of Older Persons.

Ms. Frank is a fellow of the Foreign Policy Association and serves as Chairperson of the United Nations NGO Committee on Aging.

Prior to joining AARP, Ms. Frank received a Masters of Science in Gerontology from Hofstra University in New York. During this time she was also awarded the prestigious AARP Andrus Foundation Graduate Scholarship in Gerontology in 2000, one of 10 graduate students nationwide to receive this honor. Ms. Frank is of El Salvadorian-US background and a citizen of Chile by birth. Chile is where she began her career in the field of Gerontology working with the homeless elderly.



**Barbara Crossette**, a writer on foreign affairs and United Nations correspondent for The Nation magazine, is the author of several books on Asia. She was *The New York Times* bureau chief at the UN from 1994 to 2001 and earlier a *Times* chief correspondent in Southeast Asia and South Asia. She has also been a diplomatic correspondent in Washington and a reporter in Central America, the Caribbean and Canada. In New York, she was deputy foreign editor and senior editor in charge of the *Times'* weekend news operations. Before joining the *Times*, Ms. Crossette was an editor and writer for *The Birmingham Post* in Birmingham, England.

In 1991, Ms. Crossette won the George Polk Award for foreign reporting for her coverage of the assassination in India of a former prime minister, Rajiv Gandhi. In 1998,

she won the 25-year achievement award of *The Silurians*, a society of New York journalists, and the annual prize for international reporting from *InterAction*, a coalition of more than 150 international nonprofit aid and development organizations. In 1999, she received the Business Council of the United Nations' Korn Ferry Award for outstanding reporting on the organization, and in 2003 the United Nations Correspondents' Association's lifetime achievement award. In 2008 she received a Fulbright Award for contributions to international understanding.

Ms. Crossette has been a member of the adjunct faculty of the Columbia University Graduate School of Journalism, a Fulbright teaching fellow in journalism at Punjab University in Chandigarh, India, the Ferris Visiting Professor on Politics and the Press at Princeton University and a seminar leader in international affairs at Bard College. In 2003, she led a journalism workshop in Phnom Penh for writers and editors from Vietnam, Cambodia, Laos and Burma. She was a Knight International Press Fellow for 2004-2005 in Brazil, and in 2008 she worked with Cambodian journalists covering the Khmer Rouge war crimes tribunal.

She is a trustee of the Carnegie Council on Ethics and International Affairs, publications board member at the Foreign Policy Association and a member of the Council on Foreign Relations.

Mr. Jean-Francis Régis Zinsou, Republic of Benin, was born in 1955 in Ouidah (Benin). He is a Career Diplomat in the rank of Minister Plenipotentiary of Foreign Affaires. He studied in the National University of Benin from 1976-1977, in Kiev State University in Ukraine from 1977 to 1983 and in the Diplomatic Academy in Vienna (Austria) from 1985 to 1987. From July –October 1987, he was a Research Fellow at the Institute for International Law and International Relations of the University of Vienna. He holds a post-graduate Diploma of the Diplomatic Academy of Vienna (Austria) (1987); Diploma of Summer Schools of the University of Vienna (Social Forecasting, Theory of International Trade, German Language) (1986); Master of Arts in International Relations of the State University of Kiev (1983); Russian Language Teacher's Certificate of the State University of Kiev (1983). Before becoming Minister Counselor in the Permanent Mission of Benin to the UN, he served as Assistant to four Ministers of Foreign Affairs of Benin, and Deputy Director for Europe Department of the Ministry of Foreign Affairs. He was posted in the Embassy of Benin in Germany as First Counselor. He was in 2004 and 2005, Coordinator of the Security Council; Assistant-Chair and Acting Chair of the Ad Hoc Working Group of the Security Council on Prevention and Resolution of Conflicts in Africa, in 2005, and in 2004 and 2005 as Vice-Chair of the Committee of the Resolution 1540 (2004) on Non - Proliferation of Weapons of Mass Destruction. In 2004, he was Assistant - Chair of the Informal Working Group of the UNSC on General Issues relating to Sanctions. Since April 2006 he has been Vice Chairman of the United Nations Disarmament Commission. He was Chairman for three years (2006-2008) of the Working Group of the Commission on Nuclear Disarmament and Non Proliferation of Nuclear Weapons. From 26 June to 7 July 2006, he served as Vice Chairman of the United Nations Conference to Review Progress made in the Implementation of the Programme of Action to Prevent, Combat and Eradicate the Illicit Trade in Small Arms and Light Weapons in All Its Aspects. Mr. Zinsou is currently the Chargé d'Affaires of the Permanent Mission of Benin to the United Nations and Chairman of the Working Group of the Least Developed Countries on Remittances.



**H. E. Ambassador Maria Luiza Ribeiro Viotti** was born in Belo Horizonte, Brazil. She has a Degree in Economics and joined the Brazilian Foreign Service in 1976. Along her career, she has extensively worked in different areas such as trade promotion, economic, social and political affairs. In Brasilia, she served as Executive Coordinator in the cabinet of the Minister of Foreign Affairs, Deputy Press Secretary, Director-General of the Department of Human Rights and Social Affairs and Director-General of the Department of International Organizations. Her first destination abroad was the Brazilian Mission to the United Nations, where she later returned as Minister-Counselor and is currently the Permanent Representative. She led the Brazilian Delegation to the negotiations that prepared the Monterey Conference on Financing for Development and also the

implementation of the International Action Against Hunger and Poverty initiative. She was Vice-Chairperson in the Preparatory Committee of the Johannesburg Summit on Sustainable Development and a member of the ECOSOC *Ad hoc* Group on Guinea-Bissau.



### H. E. Ambassador Mr. Mohammed F. Al-Allaf, Hashemite Kingdom of Jordan

Ambassador Allaf is a former Jordanian general of the Jordanian Armed Forces JAF. Commissioned in 1969 and retired in 2007, his military career mounted up to thirtyeight years in service. On the 5th of June 2007 he was appointed as an ambassador in the Ministry of Foreign Affairs. On 12 June, he was posted as Jordan's Permanent Representative to the United Nations. Between 1989 and 1991, he commanded the Jordanian military contingent in the first Jordanian contribution to the United Nations Peacekeeping missions; (United Nation Angola Verification Mission UNAVEM I & II). Upon the termination of his tour of duty in Angola, Ambassador Allaf developed the Jordanian military peacekeeping doctrine and was charged with equipping, training and preparation of Jordanian troops to serve under the UN flag. In his capacity as a former commandant of the Royal Jordanian National Defense College (RJNDC), Ambassador Allaf founded the academic grounds for the theory of

Jordan's National Security. Subsequently, he developed lines of qualification for promising military and civilian policy makers to prepare them assuming medium and high level leadership positions in the Jordanian government and beyond. As the Assistant Chief of Staff, and Chief of Strategic Planning, Ambassador Allaf headed a team of Jordanian generals to carry out the Strategic Defense Review SDR with the intention to develop the Military Strategy of Jordan for the upcoming decade. JAF's Transformation Strategy is now in place and reflects Jordan's adaptation to the evolving security environment and its commitment to peace, security and stability in the Middle East and in the World.

Ambassador Allaf holds the following degrees: M.A in national security strategy, National Defense University NDU, Washington, 2001; M.A in management and military science, Mu'ta University, Jordan, 1997; Diploma in command and general staff functions, Command and General Staff College CGSC, USA, Ft. Leaven Worth, 1984; B.A in military science, Mu'ta University, Jordan, 1983; Diploma in field command and joint staff, Royal Jordanian Joint Command and Staff College RJJCSC, 1983; Diploma in tactical operations, U.S Infantry School, Ft. Benning, 1980.

Upon his appointment as PR His Majesty the King awarded Ambassador Allaf the Medal of Independence of the first degree. He is also honored with three UN Medals for his military service in UNAVEM I & II.

## H. E. Ambassador D. Juan Antonio Yáñez-Barnuevo, Spain



Born in Coria del Río, Seville (1942). Ambassador Yáñez-Barnuevo has a Master's Degree in Law (Madrid, 1963); Diploma in International Law (Cambridge, 1976). He has been a member of the Spanish Diplomatic Service since 1967 and received Full Ambassadorial rank in 2006. He has been a member of the Spanish Delegation to the UN General Assembly (many sessions, since 1968), the UN Conference on the Law of Treaties, the UN Conference on the Law of the Sea, the UN Conference on the Representation of States in their Relations with International Organizations, the UN Conference on the Succession of States in Respect of Treaties. He was Deputy Permanent Representative of Spain to the Council of Europe (1978-1982); Head of the International Department at the Prime Minister's Office (1982-1991); Ambassador, Permanent Representative of Spain to the United Nations (1991-1996). Vice-Chair of the GA Working Group on the Agenda for Peace. Member of the Groups of Friends for

the peace processes for El Salvador and Guatemala; Head of the Spanish Delegation to the Conference on review and extension of the Nuclear Non Proliferation Treaty (1995); Ambassador-at-Large, Head of the Spanish Delegation at the negotiations leading to the establishment and operation of the International Criminal Court (1997-2004). He has been Ambassador, Permanent Representative of Spain to the United Nations (since May 2004) and has represented Spain in the Security Council (1993-1994 and 2004); Co-Chair of the consultations leading to the adoption by the General Assembly of the UN Counter Terrorism Strategy (2006).

**Rosemary Lane**, Acting Focal Point on Ageing and Officer-in-Charge, Social Integration Branch, Division for Social Policy and Development

Rosemary has worked at the United Nations since 1984 in a number of capacities in the Department of Technical Cooperation for Development, the United Nations Drug Control Programme in Vienna and most recently in the Department for Economic and Social Affairs, Division for Social Policy and Development as a Social Affairs Officer. She has worked on issues of ageing since 1993 and was a member of the secretariat for the Second World Assembly on Ageing in 2002. She was a main contributor to the drafting of the Madrid International Plan of Action on Ageing that was adopted at the World Assembly. Since the Madrid Assembly she has concentrated her work on

promoting the implementation of the Plan of Action at the national level, and in particular focusing on the provision of technical assistance to Member States. She was recently appointed Acting Focal Point on Ageing and Officer-in-Charge of the Social Integration Branch of the Division for Social Policy and Development. Rosemary is from the United Kingdom and has an MA in Social Policy from the State University of New York.

## Afternoon Sessions



**Susanne Paul**, President of Global Action on Aging (GAA), has worked on ageing advocacy at the United Nations since 1988. In May 2009 she urged colleagues on the UN's Expert Working Group to take up a Human Rights Convention on Ageing. At present, Susanne co-chairs the NY NGO Subcommittee to Promote a Human Rights Convention on Aging. Earlier, Susanne chaired the NY NGO Committee on Ageing, 1992-1995, and initiated the annual UN programs that evolved into the International Day of Older Persons. In 1998, GAA organized the first international conference on the "Human Rights of Older Women," that influenced the 2002 Madrid International Plan of Action on Ageing. Today, GAA's staff and interns post twice, weekly reports and news items on aging topics for readers in more than 152 countries via www.globalaging.org. She is author of *Humanity Come of Age*, Risk Press, Geneva.



**Nora Berra**, Secrétaire d'Etat aux Ainés, France, was born in 1963 in Lyon. She began her political career as a town councillor in Neuville sur Saône (Rhône) from 2001 to 2008. In 2004 she continued her political action by becoming a joint candidate in the 2004 European elections. Since 2008 she has been town councillor for Lyon where she was elected in the 8th District. She renewed her commitment to Europe by standing in the June 2009 European Elections and was elected MEP. Nora Berra became Minister for Older People at the end of June 2009 in Prime Minister François Fillon's fourth government. Having completed her pharmacology internship at the *hôpital Edouard Herriot*, in 1992 she went on to practise in the Renal Function Test Department. From 1992 to 1999, she taught in two nursing schools in Lyon and, in parallel, supervised interns and students. For 10 years, between 1999 and 2009, she worked as a doctor in French and international pharmaceutical laboratories in the

following fields: HIV, Hepatitis B, and Cervical cancer. In addition, from 1991 to 2009, Nora Berra also practised at the immunology clinic of *l'hôpital Edouard Herriot*, where she was mainly responsible for patients suffering from HIV. She built on this involvement as a member of the network of health professionals *ville-hôpital*, training general practitioners in HIV care. She continued her research as an investigator in clinical trials producing several publications. Finally, her commitment to social issues was marked by the creation in 1996 of a HIV prevention programme and her involvement with French and international associations for cultural diversity. Nora Berra became the French representative of the international association 'Women Without Borders' in 2008.

She has a Doctorate in medicine from the *Université d'Oran*; Doctor in several pharmaceutical laboratories from 1999 to 2009; In practice at the Clinical Immunology Department of *l'hôpital Edouard Herriot* in Lyon, from 1991 to 2009; In practice at the Renal Function Test Department of *l'hôpital Edouard Herriot*, 1992. She is a Member of the European Parliament, since 2009; Town Counsellor for Lyon and elected in Lyon's 8th District, since 2008; Town Counsellor for Neuville-sur-Saône (Rhône), from 2001 to 2008. She also serves as Minister for Older People at the Department for Work, Social Relations, the Family, Solidarity and Urban Issues since June 2009.



**Dr. Luciano Di Héctor Cesare,** Director Ejecutivo Nacional de PAMI Argentina. He is a Medical Doctor, Graduated from Universidad Nacional de Cuyo, Argentina; Masters Degree in Management of Health Systems and Services, University René Favaloro, Argentina; Masters in Public Health, Universidad; Masters in Business Administration, Universidad del Centro de la Provincia de Buenos Aires, Argentina; Ph.D. in Medicine, Universidad del Salvador. Dr. Di Cesare is currently the Head of the Masters Programme in Management and Development of Social Security, University of Buenos Aires (UBA). From 1991 to 1993, he was General Director of Auditing, Caja de Servicios Sociales (Official Health Insurance Provider, Santa Cruz, Argentina); 1995 - 1999 as Manager,

Medical Emergency Unit, Government of Santa Cruz, Argentina; 1999 - 2003 as CEO, Caja de Servicios Sociales (Official Health Insurance Provider, Santa Cruz, Argentina); 2003 - 2004 as Coordinator for Social Policy, Ministry of Social Affairs, Province of Santa Cruz, Argentina; 2004 – 2006 as Executive Coordinator, Nacional Institute for Social Services for Retirees and Pension Holders (I.N.S.S.J.P.); 2006 – 2007 as Deputy Executive Director, I.N.S.S.J.P.; and since 2007 as Executive Director, I.N.S.S.J.P. Dr. Di Cesare coordinates the Advisory Scientific Committee for the Health Ministry.



## Dr. Alexandre Kalache, Global Ambassador, HelpAge International

Alexandre Kalache, MD (Rio de Janeiro); MSc (London University); PhD (University of Oxford). He is the Senior advisor to the President on Global Ageing, NYAM and director International Centre for Policies on Aging, Rio de Janeiro; Global Ambassador on Ageing, HelpAge International; Senior Policy Advisor, International Association of Gerontology and Geriatrics; Directed the WHO Global Program on Ageing from 1995 – 2008; Founded Epidemiology of Ageing unit at London School of Hygiene & Tropical Medicine (1984-95); Senior lecturer at Oxford University (1977 – 1984)



**Javier Vasquez**, Human Rights Law Advisor, Pan American Health Organization He is a graduate of *Washington College of Law, The American University*, Washington, D.C.; Master's Degree (LL.M) in International Legal Studies, 1996. His main areas of study included: International Human Rights Law, the Inter-American System of Human Rights and critical issues pertaining to the right to health and other related human rights of vulnerable groups such as persons with disabilities. He is *Human Rights Advisor* (1999-to date), for the PAN AMERICAN HEALTH ORGANIZATION (PAHO) /REGIONAL OFFICE OF THE WORLD HEALTH ORGANIZATION (WHO) AND SPECIALIZED AGENCY OF THE ORGANIZATION OF AMERICAN STATES (OAS); Area of Technology and Health Services Delivery (THS)/Department of Legal Affairs (LEG), Washington D.C. He advises PAHO's Member States in collaboration with its Representation offices on international human rights issues and strategies to improve the right to the highest attainable

standard of health and other related human rights; on the formulation/review of national public health laws, polices, practices; and to structure public health services consistent with international human rights treaties and standards. Serve as the WHO focal point for human rights initiatives in the Americas in collaboration with WHO Headquarters (Geneva). He has officially conducted activities of technical collaboration and officially visited up to date 21 countries of PAHO/WHO. He is *Staff Attorney*, for the ORGANIZATION OF AMERICAN STATES (OAS), INTER-AMERICAN COMMISSION ON HUMAN RIGHTS (IACHR), Washington D.C. May 1997-May 1998 in which he is the recipient of the *Romulo Gallegos Fellowship*. He handled the first decision issued by the Inter-American System regarding violations to the human rights and fundamental freedoms of a person with a mental disability known as "the case of Victor Congo" which interpreted the American Convention on Human Rights in a manner consistent with international/regional health standards and European Human Rights Jurisprudence in the field of psychiatry and disability rights; He is a Visiting professor at *American University (Washington College of Law); Georgetown University (Law Center); University of Maryland (Law School*) and *Yale University (Public Health School*) where conducts seminars on the application of human rights law in the context of public health, the right to health and disability.

She frequently lectures about her current activities at various schools of social work. Ms. Hamlin has planned and participated in numerous conferences locally, nationally and internationally. She presented educational programs for agency staff and community groups in home care services, care giving, and program and advocacy development. Ms. Hamlin has published articles on a variety of topics related to gerontology in national and international journals. Ms. Hamlin is a member of the Advisory Council of the Brookdale Center on Healthy Aging and Longevity of Hunter College of the City University of New York.
